SPONSOR AFFIDAVITS MUST BE NOTARIZED. They must be signed by the sponsor in the presence of a notary public, the notary public must sign the form and the official seal of the notary public must be on the affidavit. There are notaries in all countries, though the names for them may be different. Notaries are officials licensed by the nation or regional government to take sworn statements for courts of law or to witness contracts and property deeds.
