Transfer decisions are mailed on a rolling basis, usually within four weeks after the application is received. Students applying to the School of Art & Design for spring admission have an application deadline of November 15. Students applying to the School of Art & Design for fall admission have a deadline of February 1 if they have less than 24 studio art credits, otherwise the deadline is March 1. Students who apply by February 1 and are accepted for the fall semester, must submit a \$300 deposit no later than May 1. If accepted for the spring semester, the deposit is due no later than January 1. Students accepted after those dates must submit a deposit within two weeks of notification.

It is University policy to show full faith in the Associate of Arts (A.A.) or the Associate of Science (A.S.) degrees offered by accredited two year colleges. Therefore, the maximum credit hours required to complete the associate's degree program are accepted in transfer. Associate of Applied Science (A.A.S.) programs will be evaluated on a course-by-course basis. If the student has attended a junior college and has not completed an associate's degree, AU will accept a maximum of 60 credits (junior standing).

Please note that grades lower than a "C" will be accepted in transfer only if part of an associate's or baccalaureate degree. Alfred University accepts college credits from those U.S. colleges and universities that are accredited by one of the regional accrediting bodies, such as the Middle States Association of Colleges and Schools. Credits earned at U.S. institutions that are accredited instead by one of the recognized national accrediting organizations, such as the Accrediting Council for Independent Colleges and Schools, will be considered for transfer of credit case-by-case.
