Each semester Alfred University will provide Borough of Manhattan Community College with the following information: a) the number of BMCC students who applied to the program; b) the number of BMCC students who were accepted into the program; c) the number of BMCC students who enrolled and; d) the aggregate GPA of these enrolled students.

This articulation agreement will be publicizing on the Borough of Manhattan Community College website and the Alfred University website. Transfer advisors at BMCC will promote this agreement with eligible students.


